

SPECIFICATIONS

Each artist may submit two original works in any art medium completed in the last two years. All works must be suitably framed with hooks/wire attached for hanging. Works on paper should be framed under plexiglas. **NO GLASS ACCEPTED.** Photography is not included in this show. Works done under classroom supervision are not acceptable. Works requiring special or difficult installation may not be acceptable.

Size Limit - 60" Longest Dimension (including frame)

DELIVERY

Works being submitted for jurying should be delivered to the Jan Dempsey Community Arts Center during the following times:

Friday, September 22 from 10 a.m. to 4 p.m.

Saturday, September 23 from 10 a.m. to 4 p.m.

LIABILITY

Every precaution is taken to protect all entries. However, only those works selected for exhibition will be insured within limitations while on display. The Auburn Arts Association will not be liable for poorly constructed works. Neither the Arts Association nor the Arts Center will be responsible for unclaimed works after the announced pick-up dates. Works picked up by anyone other than the artist must have written authorization to do so. By submitting an entry, entrants agree to all conditions of this exhibition.

GENERAL

All forms must be completed according to instructions. Artists must fill out the attached entry and notification cards and deliver them with the entry fee and words on the above delivery dates.

Size and framing requests must be adhered to.

The Arts Association reserves the right to photograph any works submitted for publicity purposes.

NOTIFICATION
