Each artist may submit **three** original works in any photographic medium completed in the last 3 years. All photographs must be matted, or mounted, with **white** boards. Unframed works should be presented in either **16x20"** or **18x22" white** mats/mounts. Other sizes must be suitably framed under Plexiglas. **NO GLASS ACCEPTED.** Note: Framing should be appropriate for photographs and works on paper.
